Thank you to this member for asking a question that many members likely have and for identifying the topic of my article this month. Each month I attempt to explain an aspect of the organization. I believe that demystifying the organization creates an environment in which more members feel more welcome to participate.

The Management Team is comprised of the SFCP President and the leader of each of the Divisions and groups that report to the President. Click here to see the [organizational chart](#). The Management Team oversees SFCP programming (e.g., psychoanalytic training, psychoanalytic psychotherapy training). The Board of Trustees is responsible for the overall health of the organization. This includes areas such as the mission, strategy,

Key points and votes from the November Board meeting:

- The Board of Trustees Annual Meeting will occur in September (rather than June) next year and will serve as a welcome gathering for SFCP members. Members will receive an announcement as soon as a specific date is determined.
- The Finance Committee shared that SFCP's financials continue to be on target. Please note that SFCP's annual operating budget (the money we need to sustain SFCP for the 2023-24 fiscal year) requires that SFCP meets the \$130,000 annual giving campaign goal.
- The Board voted to approve the Candidate Training Grant Proposal. Please see the [President's article](#) to read about this.
- The Board voted to approve the Member Discount Policy. Please see the [President's article](#) to read about this.
- Beth Steinberg provided an update from the Equity and Inclusion Steering Committee about how the group is working together and beginning to consider next steps.

The next Board meeting will be held by Zoom on Monday, December 18 from 7:00 – 9:00pm.

# SFCP President's Report

As we approach the end of 2023 and the midpoint of the academic year, I want to express my sincere thanks to the hundreds of SFCP members involved in the ongoing educational and service efforts of the Center. It is truly inspiring to see the dedication and commitment from all of our volunteers who devote countless hours toward SFCP programs, making SFCP one of the largest and most active psychoanalytic centers in the country. Our hope is to continue to evolve as a field and as a Center so as to meet the psychoanalytic educational needs of all contemporary psychoanalytic clinicians and students in our community – both now and in the future. All SFCP members are invited to participate in a Center-wide meeting to develop the next **SFCP Mission statement** on **Sunday, April 28, 2024**, to shape our future direction as a Center.

I also want to let you know about two important initiatives that were passed by the SFCP Management Team and approved by the Board of Trustees this past month:

1. **SFCP Member Discount Policy** - In order to support membership and offer more benefits in a non-hierarchical way, SFCP is implementing new discounted rates for all members for program registration and continuing education (CE/CME) credits. Effective immediately, **SFCP members will now receive free CE/CME credits and a 50% discount on registration fees** for all single event programs, as well as a 10% discount plus reduced CE/CME fees on multi-week Extension Division programs. The full details of the discount policy are shown at this link: [SFCP Member Discount Policy](#). The overall goal of this policy is to acknowledge the multiple contributions of our members by offering a discount which will both benefit members as individuals, as well as support their important program work for our community. It is also our hope that improving the cost-effectiveness of membership and greater program accessibility will bolster our Center-wide equity and inclusivity efforts.

2. **Candidate Training Grants for Equity and Diversity** - In accordance with a January 2023 ratification vote by all analyst and candidate members (based on majority-supported initiatives in the All-Member Survey on Diversity & Accessibility in Analytic Training - Fall 2022), SFCP is establishing a new Candidate Training Grants for Equity & Diversity Program to help cover costs of analytic training for candidates who identify as a person of color (POC) and candidates with financial need. All funds will be collected via voluntary contributions from SFCP Members. The Candidate Training Grant program was developed over this past year by a Task Force chaired by former Board Chair **Paul Sorbo**, and was passed by the Board of Trustees in November 2023.

The goal of the Candidate Training Grant program is to make psychoanalytic training more affordable and accessible to individuals affected by systemic inequities which have previously served as barriers to pursuing psychoanalytic training (e.g. race-based or class-based inequities). Any candidate who self-identifies as BIPOC and/or who self-identifies as having financial need is eligible if they are enrolled in the SFCP Psychoanalytic Training Program, or have accepted an offer of admission for the upcoming year.

To take full advantage of *tax-free methods of fund distribution*, the first priority will be to use all donated funds to offer *tax-free tuition & fees credits for psychoanalytic training* to all eligible candidates – up to the full amount that can be covered by the amount of donations received that year (full tuition and fees = \$6740 per candidate in 2024-25). If donated funds in a given year are insufficient to cover the full tuition and fees amount, all collected funds will be distributed evenly amongst eligible candidates. If donated funds in a given year *exceed* the maximum amount that can be offered as a tax-free tuition credit, any additional donated funds will be distributed in the form of Candidate Training Grants paid directly to the

candidate, to help offset additional costs of training such as required supervision, etc. (Note: any training grant amounts paid to candidates in excess of the tax-free tuition credit is considered taxable income by the IRS). The Candidate Training Grant program will be closely coordinated with the Enrico Jones Fund for Equality and Excellence to ensure maximal support of SFCP trainees across all programs (analytic training, psychotherapy training, and CCSW). Because this initiative is brand new, there is no way to estimate how much money will be available through donations, and how soon any training grants can be offered to candidates. A **Candidate Training Grant Committee** chaired by PED Chair Beth Steinberg and reporting to the Board is in the process of being formed to develop fundraising efforts and procedures to implement the selection and distribution of Candidate Training Grants as soon as possible.

Lastly, I would like to acknowledge the dedicated service of several individuals who are rotating out of their leadership positions as the year winds down, and welcome those who have volunteered to take their place! The first is **Adam Goldyne** (SF-PPTP Chair) who has been serving as the Management Team representative for the Psychoanalytic Psychotherapy Educational Division (PPED) Council this past year. He will be replaced as PPED Council Rep on the Management Team by PAPPTP co-chair **Catherine Phillips** for the 2024 calendar year. In addition, the Management Team is delighted to welcome **Sydney Tan** who chairs the Committee on Groups (COG) as the first COG representative to the Management Team. Finally, we are enormously grateful to **Benjamin Fife** for his tremendous work as CAPPTP Program Chair for the past several years. Benjamin is stepping down as of this month, and the CAPPTP program is now seeking additional members for their Steering Committee. I want to end by again expressing my gratitude for the SFCP community and reiterating my appreciation for all of you, and the challenging work you are doing. I hope you all get some time to relax over the SFCP Winter break and that you have a lovely New Year!

# Equity & Inclusion Steering Committee Communication #2\*

The Equity and Inclusion Steering Committee has been meeting twice per month for several months. We started by laying the groundwork for working together and drafted vision and mission statements for our group in advancing the process of equity and inclusion at SFCP. In August, we added new members to this Steering Committee. The current makeup includes Chuck Fisher, Debora Fletcher, Karim Dajani, Jennie Merovick, Clara Kwun, Beth Steinberg, Lovina Chahal, Marcia Hodges, and consultant, David Luna.

We have not sent an update for a few months as promised because we faced a difficulty right out of the gate that has taken us a few months to represent. The group got stuck on the issue of how to create a committee with an accurate range of ideological and theoretical positions that characterize our institute and community. We can refer to our community as divided, but, for now, let us refer to it as containing a wide spectrum of difference in terms of sensibilities, theoretical orientations, ideologies, political views, basic understanding of what psychoanalysis is, degree of appreciation for the social unconscious, and degree of openness to diversity, equity, inclusion (DEI) efforts. We spent several meetings trying to work through this problem and came to the realization that our experience in the committee mirrors or reproduces the wider community deadlock that characterizes our current state of affairs. We have come to the realization that this struggle is a symptom of the overall problem at SFCP.

In facing this struggle and thinking through this realization, the group unanimously agreed that the best place for us to start for constructive action is to focus on how to respond to the most urgent need as expressed by a wide range of candidates and students of our programs - developing and administering curricula that accurately present the history of the social within psychoanalysis and centers the voices who have been typically marginalized. We all thought this is an action item that we as a community can likely agree on. However, we are aware that the devil is in the details. How do we facilitate curricular changes while supporting, developing and recruiting faculty? Our next step will be to determine a set of recommendations and actions that would support this aim.

The committee has promised to communicate frequently and to be transparent with our process. We encourage the people in the wider SFCP community who are receiving our dispatches to communicate with us as well. # Report from the Chair of the Psychoanalytic Education Division

Dear SFCP Community-

As we wind down towards the holidays, the psychoanalytic training program continues to roll along, with four classes of candidates attending classes on Friday mornings, and our PED committees working constructively.

The PED Committee continues to examine our processes, policies and procedures in order to prioritize the candidate experience and to support candidate autonomy and creativity, and to continue to increase accessibility of training. In addition, as the Chair of the PED, I continue to be committed to reflecting on myself as a leader and inviting feedback in order to learn about my own areas of unconsciousness.

Here are a few of the things we have been working on this fall:

1. We approved a new procedure regarding candidates' inclusion in their annual PGC Reviews. Beginning January 2024, candidates will be invited to attend the last 15 minutes of their Progressions (PGC) review after the PGC and supervisors have finished their discussion. We are planning to review the process with the help of feedback from the community in the summer. [Please see the new policy in the Candidate Handbook under [Candidate Progression](#).]
2. In addition, the PED has removed the policy that first year candidates are not permitted to begin a control case until they have been reviewed by the PGC in February in order to receive "First Case Permission." Candidates are now encouraged to begin cases whenever they have a patient in 3-5x/week treatment and a supervisor and feel ready to do so. 3. Given all of the changes we have been making to policies and procedures as well as the ethos within the PED around candidate training, this fall we also developed a document for SFCP Supervising Analysts containing the most current policies and procedures impacting SA's. [If you are interested in seeing this document, you may [click here](#).]
4. Lastly, we are extremely pleased that SFCP is now ready to implement the **Candidate Training Grant Program for Equity & Diversity** to help cover costs of analytic training for BIPOC candidates and candidates with financial need. In accordance with the January 2023 ratification vote by all analyst and candidate members (based on majority-supported initiatives in the *All-Member Survey on Diversity & Accessibility in Analytic Training - Fall 2022*), the majority-supported proposal to [Establish Candidate Training Grants](#) - which had been referred to the Board of Trustees since it required legal and financial review per non-profit law - has now been formally approved by the Board. The goal of the Candidate Training Grant program is to make psychoanalytic training more affordable and accessible to individuals affected by systemic inequities which have previously served as barriers to pursuing analytic training (e.g. race-based or class-based inequities). **Please see Maria Longuemare's President's Report in this newsletter above for more details!**

# Message from the Committee on Groups:

## SFCP ANNUAL GROUP RELATIONS WEEKEND MARCH 23 & 24, 2024

The Committee on Groups (COG) is hosting the annual SFCP Annual Group Relations Weekend on March 23 & 24th, 2024, and would like to invite you to participate.

What is “Group Relations?”

Group Relations utilizes a methodology to understand authority, leadership, power, and the dynamics within groups, organizations, and systems. The group relations conference will engage participants in an experiential learning process – a blend of “here-and-now” events and reflective sessions. In “here-and-now” events, participants examine the current moment, focusing on unconscious dynamics playing out in the group-as-a-whole, rather than focusing only on intrapersonal or interpersonal dynamics. Reflective events encourage participants to think and reflect upon their experiences. It is not uncommon for the learning process to be transformative, influencing how participants perceive themselves, their roles, and the groups and organizations to which they belong.

Given that all aspects of life manifest within groups, including when working in dyads, this group relations retreat seeks to deepen participants' understanding of their roles, citizenship, leadership, and authority. Additionally, it aims to foster the development of personal agency and creativity within the dynamics of the group. We hope to generate meaningful conversations that explore a deeper understanding of ourselves and others within a group setting. The opportunity to share one’s thoughts openly and spontaneously within the group, guided by experienced facilitators, can be invaluable for comprehending group life, organizational dynamics, and the complexities of working in groups.

### **Location & Registration:**

We will meet on Saturday and Sunday, March 23 and 24, 2024, at SFCP from 9 am to 5 pm. These two days will include working in both large and small groups.

All are welcome. We have room for 24 participants; 10 spots will be filled by COG members, and 14 openings remain. We aim to be inclusive and will work to create a group that represents diversity of membership on many levels. We welcome new participants to the group process experience and encourage those who have participated before to join us again.

Would you like to meet with an analyst to discuss your questions about psychoanalytic thinking and clinical work? We'd love to meet with you! The Mentoring Program at SFCP matches participants with analyst mentors to discuss the mentee's interest in psychoanalytic work.

The Mentoring Program is open to mental health clinicians at all levels of training and experience, who are SFCP Community Members, an easy and fun community to join! Mentors meet once a month with mentees for the academic year.

Examples of Topics to Discuss:

- Information, resources and literature to help a mentee explore particular areas of interest. For example: work with particular populations such as trauma survivors; current thinking about LGBTQ issues; the impact of race, class and culture on psychological life; child work; mindfulness; research about psychoanalytic process; and psychoanalytic interfaces with other fields such as poetry, literature, neurosciences
- How to choose among current activities, programs, courses, and services offered by SFCP that are relevant to the mentee's interests and stage of training
- Questions about developing as a psychoanalytic psychotherapist and about psychoanalytic training
- Connecting the mentee with colleagues who the mentor thinks might be a valuable resource based on the mentee's interest in a particular subject

He has published extensively on child development and its disturbances in the International Journal of Psychoanalysis, and with Nathan Szajnberg authored *Lives Across Time: Paths to Emotional Health and Illness From Birth to 30 in 76 people*. He has also developed, with B. Kay Campbell, the Massie-Campbell Scale of Attachment During Stress Scale which is a screening tool for troubled parent-infant interaction which is in use world wide. Dr. Massie is based in Berkeley, CA.

**Nathan Moses Szajnberg, MD** completed psychoanalytic training at the St. Louis Institute. He is the retired Freud Professor of Psychoanalysis at the Hebrew University. He has received two NIMH awards in Adolescence and Infant Psychiatry and worked with Dan Stern, Bruno Bettelheim, Peter Blos and Bob Wallerstein. He was the Wallerstein Research Fellow in Psychoanalysis 2005-16. He received the Ticho Award in 2012. He has written several books on development in Ethiopian children, Israeli soldiers and co-authored *Lives Across Time* with Henry Massie.

TFP is based on a contemporary object relations model of psychological functioning that incorporates findings from attachment and neurocognitive research. The treatment focuses on internalized representations of self and other that organize the patient's interpersonal experience.

**Diana Diamond, PhD**, is a clinical psychologist and psychoanalyst who specializes in theory, research, and treatment of borderline and narcissistic personality disorders. She is Professor Emerita in the Doctoral Program in Clinical Psychology at the City University of New York and Senior Fellow at the Personality Disorders Institute at Weill Cornell Medical College. She is also a professor in the New York University Postdoctoral Program in Psychotherapy and Psychoanalysis, and is on the faculty of the New York

Psychoanalytic Society and Institute. She is the recipient of several awards, including most recently the Aaron Stern distinguished visiting professor award from Weill Cornell Medical College for her contributions to understanding the etiology and treatment of narcissistic pathology. She is an honorary member of the American Psychoanalytic Association and heads their research committee for the Department of Psychoanalytic Education. Dr. Diamond currently teaches, lectures, and supervises TFP nationally and internationally, and is in private practice of psychoanalytic psychotherapy and psychoanalysis in New York City and Sag Harbor, NY.



**Frank Yeomans, MD, PhD** is Clinical Associate Professor of Psychiatry at the Weill Cornell Medical College, Director of Training at the Personality Disorders Institute of Weill-Cornell, and Adjunct Associate Clinical Professor of Psychiatry at the Columbia University Vagelos College of Physicians & Surgeons. He is president of the International Society for Transference-Focused Psychotherapy, an Honorary Member of the American Psychoanalytic Association, and past Chair of the Group for the Advancement

of Psychiatry Committee on Psychotherapy. Dr. Yeomans' primary interests are the development, investigation, teaching, and practice of psychotherapy for personality disorders. He headed the specialized unit for patients with Borderline Personality Disorder at Weill Cornell Medical Center for ten years and has subsequently focused on the practice and teaching of TFP nationally and internationally.

In addition to their individual published works, Dr. Diamond and Dr. Yeomans have co-authored *Treating Narcissistic Pathology with Transference-Focused Psychotherapy* with Barry Stern and Otto Kernberg.


