SFCP Board Chair Report

As SFCP works diligently on issues of Diversity, Equity, and inclusion (DEI), it's important that the Board of Trustees also thinks about and understands these issues. To this end, at the April Board meeting, Trustees engaged in a one-hour Identity Consciousness session. Tiffany Enos, a DEI consultant in higher education (currently at Tufts University), facilitated a participatory exploration of Trustees' own identities and their relationship to them. At the end, one Trustee commented that they wish the Board had engaged in this work earlier. I hope to continue the Board's understanding and growth in this area.

Key points from the April Board meeting:

- I reported that the Vision and Mission event had taken place the day before and ended with a solid start to creating vision and mission statements for SFCP. A group is forming to take the work of that day, draft statements, and get input from all areas of the organization.
- The Finance Committee reported that SFCP remains on budget for this academic year. This will remain true if the Annual Campaign reaches its goal of \$130,000.

•The Annual Giving Campaign Committee reported that \$95,848 has been raised to date.

Regarding other honors – each year the SFCP Management Team recognizes members who have made unique contributions to SFCP with a **Distinguished Service Award (DSA)**. Finally, in less welcome news, SFCP is required to entirely **revamp our CE/CME application procedures** in order to comply with newly announced procedures and fee structures of our sponsoring organization, APsA. Despite significant increases in fees imposed by the new procedures, APsA sponsorship remains the most affordable route for SFCP to continue to offer CE/CME to our members. The SFCP leadership, office staff, and Continuing Education Chair **Megan Goodwin** are developing a plan to respond to these changes with the goal of continuing to maximize CE/CME offerings while mitigating the increased costs. New SFCP procedures will be communicated to all programs as soon as the details are ironed out, but in the interim, please be prepared for the following changes:

- New CE/CME application fee of \$300/application for private study groups
- Maximum of 25 CE/CME credits per application
- Training programs and multi-week Extension Division programs will need to bundle their courses as much as possible to reduce the overall number of applications submitted per program (new caps are in place)
- New CE/CME application form is being developed to streamline the process (perhaps the only silver lining)

<u>New Post-Covid Requirements for Supervision, Control Cases and Personal Analysis as of September</u> <u>2024</u>

Please note that the **New Post-Covid Requirements for Supervision, Control Cases and Personal Analysis** will be in place as of September 2024. The new requirements emphasize respect for the existence of ongoing medical concerns while re-emphasizing the importance of in-person experience during analytic training where possible. These new requirements are being treated as provisional and will be reviewed after one year with the help of feedback from the community. Please see the <u>Candidate</u> <u>Handbook</u> for these new Policies and Procedures, as well as the new policies and procedure about requesting Exceptions.

Group Relations Weekend Recap

The Committee on Groups hosted the SFCP Annual Group Relations Weekend with co-facilitators Leonard Levis, PhD, and Janice K. Wagner, LCSW, on March 23rd and 24th. A total of 20 participants attended and engaged in various experiential learning events designed to foster self-inquiry in relation to group life. These experiences included small and large process groups, intergroup sessions, a social dreaming matrix, and a large review group. The events helped participants reflect upon their experiences in the here-and-now, explore unconscious dynamics within the group as a whole, and learn more about how they perceive themselves, their roles, and the groups and organizations to which they belong. Many participants shared that the weekend offered a rich opportunity to forge meaningful connections and gain a better understanding of group life, institutional dynamics, authority, leadership, power, and the dynamics that operate within groups – at the Center as well as within social systems.

ART AND CRAFT: IN AND OUT OF THE CONSULTING ROOM

On Wednesday May 1, 2024, the CCSW held our last clinical evening of this academic year. It was focused on three clinicians who are also serious artistsand for that reason we decided to meet in person. Our first of three artists was Daniel Yu, LCSW who is a serious chef and he talked about the links between cooking and doing therapy, followed by a meditation on beauty and pain in both mediums. He was generous in sharing personal stories about losing his mother, and how cooking brought life back into his family. Our second artist was Jane Dulay, MD who is a graduate of SFCP and also a figurative painter. She talked about making the invisible visible and the importance of relationships in her work. Our third pair of artists were Tim Kim, PsyD and Johnny Huy Nguyen, a Bay Area dancer. They danced and sang in a way that showed the beauty and intimacy of closeness and the complicated feelings it evokes. All the artists talked of their wish to bring new energy into the Center with their work, and I think they accomplished this beautifully. It was gratefully received by the audience there that night who formed an intimate community amongst themselves and with the artists, and knew it was part of something special.

All our artists emphasized the importance of the tensions and collaborations between expressions of silence and words/images/music and movement. They also all talked about the importance of relationships. Some who attended said that the auditorium will never look the same to them- and I hope that this is truethat we can all move together to bring art, and the joy and suffering it helps us be in touch with- into our community life at the Center.

Retirement from Practice – Facing a Complex Issue

Editor's Note: Retirement is an issue that analysts rarely talk about. Yet it is a career issue with powerful ethical, personal, and clinical significance. With this in mind, sixteen SFCP members – a mix of recently retired and practicing members attended an informal three-hour discussion in April. Here are the themes and issues that came up:

Themes:

- The relationship with patients in analytic treatments is uniquely intense. It cannot be found in "civilian life."
- The sense of responsibility for the psychic condition of another is weighty but satisfying. This is particularly true for long-term patients who seem to need treatment to maintain progress and stability.
- Most analysts feel that they "get better" at the work with experience; this creates a tension.
- Retirement is a way to reverse the "narcissistic tilt" built into the patient-analyst relationship, i.e., to "have more for oneself." Many of us chose a therapeutic field out of a need to be in the helping role, but do we need to look out for ourselves better?
- Several members spoke about having begun analytic training in mid-life, and therefore wanting to continue working to have more analytic practice.
- There is a valorization of keeping going some analysts have worked past age 100! (There is controversial literature suggesting that longevity may be a result of keeping going.)
- Keeping going is in tension with two possibilities that may be damaging for patients 1) the analyst's declining physical or cognitive capacities; 2) sudden closing of practice due to serious disability or death.[1] We discussed how these issues are often avoided by analyst and patient, and wondered whether they might be better attended to by making them more part of post-graduate education and consultation.
- There is no ritual event for retirement at the institutional level. Acknowledging a member's career and SFCP roles could play a valuable function for both members and the organization.

Retirement from Practice – Facing a Complex Issue cont.

Specifics from retired analysts:

- The decision to retire was usually a gradual one, although life changes brought the issue to the fore sometimes. Most noted that they gradually saw fewer hours, and that at some age often in mid-70's it felt unfair to take on new analytic or intense psychotherapy patients (since one can't make an implicit open-ended promise).
- Individual life situations had a significant role in the decision.
- Some of the retired analysts said that they gave patients a year's notice; others announced to patients in relation to the specific meanings that they anticipated. Telling patients was often the most emotionally challenging aspect of retiring.
- Most of the retired analysts found that the transition into a new "developmental phase" was less traumatic than expected. Several spoke about new projects; some of these were ways of continuing in a service role and some were more deferred sorts of personal meaning (travel; writing; art).
- The time between announcement and ending was emotionally intense for most patients and analysts. Issues came up that had not surfaced before or came up with greater intensity. Separation and loss. For the analyst this had two levels – the loss of certain beloved or intensely engaging patients; the loss of the therapeutic role.
- On a practical level, the question of termination of treatment versus referral varied.
- The issue of post-retirement contact with patients came up briefly in relation to a patient who developed a fatal illness. There was agreement that humanness overrode plan in this situation.

The participants in this discussion agreed that sharing concerns and experiences around retirement was very positive.



Jyoti Rao, LMFT


